### **Boot Rule Clarification**

As we are now in the Summer Season, we would like to remind our Officials of the Boot Ruling for British Showjumping classes that have adopted the FEI Ruling.

The ruling has recently been reformatted to clarify which classes this ruling applies to and can be seen by clicking here.

Officials are asked to ensure that this rule is applied in all relevant classes.

#### **Myler Combination Bits**

Over the past few months, it would appear there has been an increasing amount of competitors trying to compete in Pony Classes with Myler Combination Bits. Under British Showjumping Rules, Myler Combination Bits are not permitted in any Pony Classes and should not be allowed to be worn in either the arena or in the collecting ring.

## **Disciplinary List**

As part of a recent review into our Disciplinary Procedure, it has been agreed that British Showjumping will now send to all the Officials Workforce via the Officials Newsletter, the Disciplinary List showing all discipline matters reported to us. This list is for the Officials Workforce only and will help the Officials in the Disciplinary Reporting Process.

Officials are asked to keep this information protected and to treat this list with the upmost confidentiality. This means that it should not be passed to any other member or 3rd party.

Officials will be able to refer to this list when making Disciplinary Reports, however Officials are advised not to report an incident based on the content of the list, and that they should treat each incident as an individual case and report this accordingly.

Officials are reminded that they are encouraged to work as part of a team and that only 1\* (Level 2) Judges or above have the power to report discipline issues to headquarters. If another Official witnesses an incident or feels the need to report a discipline issue, they are encouraged to talk this through with the Judge at the show so this can be reported in the correct manner.

Reporting matters of discipline to headquarters is important to ensure that matters can be investigated and resolved accordingly.
