- DOCUMENTS REQUIRED**
- Identification sketches, microchip and vaccination records MUST be provided - photocopies will be accepted.
  - Sketches must show a minimum of five distinguishing features, including a microchip, any brand marks, with matching written description and must be completed, signed and stamped by a vet.
  - Breeding will be recorded on production of papers showing VERIFIED breeding - Breed papers are mandatory for age classes.
  - STALLIONS will ONLY be accepted for registration on production of approved stud book papers showing confirmed breeding on both sides. Stallions may not be jumped on a ticket and must wear stallion discs and tail ribbons (red, white and blue) at competitions at all times. Stallion ribbons and discs can be purchased via your member's online account. A surcharge will be applied to ungraded stallions, Refer to rule 41.4
  - All documents will be over stamped by British Showjumping and returned.
